1. I am tired and taken aback by Agbojidi of Onitcha ugbo's constant ghost presence and witch presence of in my home since 2019.
2. I am tired of Agbojidi feeding me with Ghost lizards and I do know this is not a crazy event but real. (Hospitalizations has not helped me recoup from the visible horror & smell of lizards which Agbojidi brings to me) He

showed up so many times that I had run out of my home two solid times hopefully that he would Desist his acts. He did not.
